contract to the supplier offering the best value for money. The main categories of the services to be provided are the following:

- 1. medical assistance in the frequent and/or long-term sick-leave procedure (e.g. home calls/visits, medical examinations, medical clearance, follow-ups, etc.);
- 2. medical assistance in the disability procedure (e.g. assessment of sick leaves, regular review of disability-pensioned staff members, advice on (partial) reintegration where appropriate, etc.);
- 3. administrative assistance (maintenance of files, documentation, storage of medicines/equipment, etc.). Services will be provided, in collaboration with 2 ECB qualified nurses, on-site at the medical centre on the ECB premises in Frankfurt-on-Main. Appropriate office and medical equipment will be provided by the ECB. The ECB is seeking through a separate open tender procedure, conducted in parallel to this procedure, a supplier for the provision of medical services with regard to occupational safety and health. While bidders may choose to tender for both services, the ECB will not award the 2 contracts to the same supplier for policy reasons.
