The European Central Bank (ECB) has tendered out the supply of electricity for the buildings located at its main address (Sonnemannstraße 20, 60314 Frankfurt am Main, GERMANY) and at the location 'Japan Center' (Taunustor 2, 60311 Frankfurt am Main, GERMANY). The main building is located in the eastern part of the city while the Japan Center is located in the city centre. The area where the buildings are is around 120 000 m². The total surface in the buildings is around 190 000 m².

27,7 GWh is estimated per year for the main building while 1,3 GWh is estimated for the Japan Center. The ECB requires regenerative (green) power supply and that the tenderer has supplied this kind of supply in the past as stated in the procurement documents.

The local net operator is Netzdienste Rhein-Main GmbH.
