The main building is located in the eastern part of the city. The area where the buildings are is around 120,000 m<sup>2</sup>. The total surface in the main buildings is around 190,000 m<sup>2</sup> and 22 GWh are estimated per year.

The Japan Center and the Eurotower are located in the city centre of Frankfurt. The Japan Center's total rented surface in the building is around 17,850 m<sup>2</sup> and 1.4 GWh are estimated per year. The ECB requires regenerative (green) power supply and proof that the tenderer has supplied this kind of supply in the past as stated in the procurement documents.
