II.1.4) **Short description:**

For the screening of its visitors and deliveries, the ECB currently uses a total of 9 X-ray screening devices purchased from the manufacturer Smith Heimann and used in its five buildings located in Frankfurt-am-Main. The screening-systems operated at the ECB are used as a stand-alone device in order to screen the relevant luggage of people directly on the spot, but also remotely via centralised remote-screening facilities. To this effect, the screeners are interconnected via networking infrastructure across all ECB buildings for communicating with centralised working places. For these functionalities compatible management software applications are required, which can only be provided by the manufacturer of the system themselves and is only functional with their proprietary communication baseline. To ensure the smooth functioning of the devices, the ECB is seeking the services of a supplier providing maintenance, repair, upgrades and extension possibilities for its screening system.

The devices no longer are under warranty by the manufacturer. The supplier must be capable of providing the following:

- full maintenance of Smith Heimann screening devices, including, but not limited to:
- safety check,
- external dose rating test,
- cleaning and calibration of X-ray unit,
- checking of X-ray beam alignment,
- cleaning and check of light barriers and light curtain,
- check of motors,
- check and lubrication of driving chains,
- UPS check,
- check of data transmission,
- creation of diagnosis report,
- checks according to DGUV V3 and tagging,
- full repair services,
- a 24/7 hotline for emergency repair,
- maximum reaction time of 24 hours for onsite presence for repair of defective devices on weekdays,
- provision of all necessary compatible spare and wear parts, storage availability of the most frequently used parts,
- provision of compatible management software applications,
- provision of additional equipment and screening devices.
