— Lot 1 includes services for the lift systems in the high-rise building (Hochhaus), which comprise 5 passenger lifts, 6 passenger lifts with TWIN lift systems, 2 firemen's and freight lifts and 5 shuttle lifts (fast moving lifts in glass shafts) and the paternoster lift;

— Lot 2 includes services for the lifts in the wholesale market hall (Grossmarkthalle) comprising of 15 passenger lifts and 1 fireman's and freight lift.

The ECB intends to award one single supplier framework agreement per lot for a duration of 48 months.
