The European Central bank (ECB) aims at entering into a contract with a provider of private security services. The selected contractor shall provide security services at four locations operated by the European Central Bank with around 5,000 persons and at the European School (around 1 600 students). All these premises are located in Frankfurt--am-Main. The initial contract duration shall be 4 years. The contract can be extended for successive periods of up to a total of 2 years. The estimated total value in section II.1.5) refers to the security services for the ECB premises (and so not for services to be provided for the European School) and to the maximum contract duration of 6 years.
