Since the year 2000 childcare is provided to children of ECB staff by various childcare providers and facilities. In total, there are currently more than 450 places available.
One of the ECB childcare facilities is the facility Knoppschachtel located in Ferdinand-Happ-Str. 55-57 in 60314 Frankfurt am Main. For this facility, the ECB was looking for a service provider. The contract will have an initial duration of 8 years plus automated extensions by 4 additional years at a time (extendable contract without a fixed maximum term) if market conditions have remained unchanged.
