The ECB was looking for a supplier which was able to provide audio and video equipment including delivery and related services in the ECB premises:

1. Sonnemannstraße 20, 60314 Frankfurt-on-Main — Main Building;
2. Kaiserstraße 29, 60311 Frankfurt-on-Main — Eurotower;
3. Taunustor 2, 60311 Frankfurt-on-Main — Japan Center.

It was possible that additional premises of the ECB in the greater Frankfurt area would also need to be equipped.

The ECB was seeking to complement equipment which was already in use and/or stock up for additional needs.
