## A) Change Request for decision

There is no new Change Requests with the AMI-SeCo for decision

On continuous basis, the Change Review Group evaluates Change Requests raised by T2S Actors and submits the finalised and complete CRs for preliminary assessment

### A) Preliminary assessments

- In the preliminary assessment, the 4CB provide the cost impact indicator, the impacted T2S domains and whether a Change Request has a performance impact
- The following Change Requests are currently under preliminary assessment:
  - [T2S-0638-SYS](#) (T2S should allow and process already matched instructions which include the counterparty's securities sub-position to be used for settlement purposes). It will be available on 21 June 2017
  - [T2S-0658-SYS](#) (T2S should allow and process already matched instructions with deviating settlement parameters on DELI and RECE legs). It will be available on 8 August 2017
  - [T2S-0659-SYS](#) (T2S should allow settlement of instructions with an 'AFTER' link to a settled instruction that was subject to conditional securities delivery). It will be available on 24 June

### B) New breakdown of the financial impact indicator

- During the RMSG workshop on the Operational Governance Framework, the CSDs requested the 4CB to analyse the possibility to have an enhancement of the current financial impact indicator provided with the preliminary assessment:

Category	Definition
<b>High</b>	Changes with an investment cost of more than 500 000 EUR.
<b>Medium</b>	Changes with an investment cost of less than 500 000 EUR, but more than 100 000 EUR.
<b>Low</b>	Changes with an investment cost of less than 100 000 EUR.

- The 4CB indicated that they could categorise the financial impact indicator into 5 categories (non-binding) – [see detailed analysis](#)

Category	Definition
<b>Very High</b>	Changes with an investment cost of more than 700 000 EUR.
<b>High</b>	Changes with an investment cost of less than 700 000 EUR, but more than 400 000 EUR.
<b>Medium</b>	Changes with an investment cost of less than 400 000 EUR, but more than 200 000 EUR.
<b>Medium-Low</b>	Changes with an investment cost of less than 200 000 EUR, but more than 100 000 EUR.
<b>Low</b>	Changes with an investment cost of less than 100 000 EUR.

- The CRG was of the opinion that the 4CB proposal would indeed provide a more granular view to the results of the preliminary assessment

### C) Change Request ranking

- The CRG also ranks Change Requests as part of the release management process
- The CRG has started a new prioritisation exercise in June 2017, based on the current CRs on hold. CRG members are invited to provide new business value indicators for the latest raised CRs (also for the old ones on voluntary basis). The aim is to have an updated ranking by the end of August 2017

### D) Status of particular Change Requests

- **T2S-0646-SYS** (Pre-formatted operational reports at specific times) was raised by the Data Access Task Force (DATF)
  - The CRG and the DATF indicated that the cost of the Change Request was significant
  - On 12-13 July 2017, the DATF will update the CR with a reduced scope following the CSD's proposal and the 4CB will do a new assessment

- The Operation Managers Group (OMG), as initiator of the CR446, indicated that the CR is required from an operational point of view as otherwise, the reconciliation would take longer in case a T2S System user instructs during the reconciliation process after a RAD
