# TIPS UHB scope and structure

- The UHB of TIPS is addressed to TIPS Actors' users in charge of monitoring their Instant Payment settlement activities and managing their local reference data in TIPS.
- These users may find in the UHB a description of all the TIPS features available in U2A mode and a detailed step-by-step guide on how to use them.
- The UHB is drafted in a way to allow users to use the GUI without any prior knowledge of the tool and with only a high-level understanding of the TIPS service and of its features.
- It is designed to be a stand-alone document, that allows using the TIPS GUI without the need to read the TIPS UDFS.

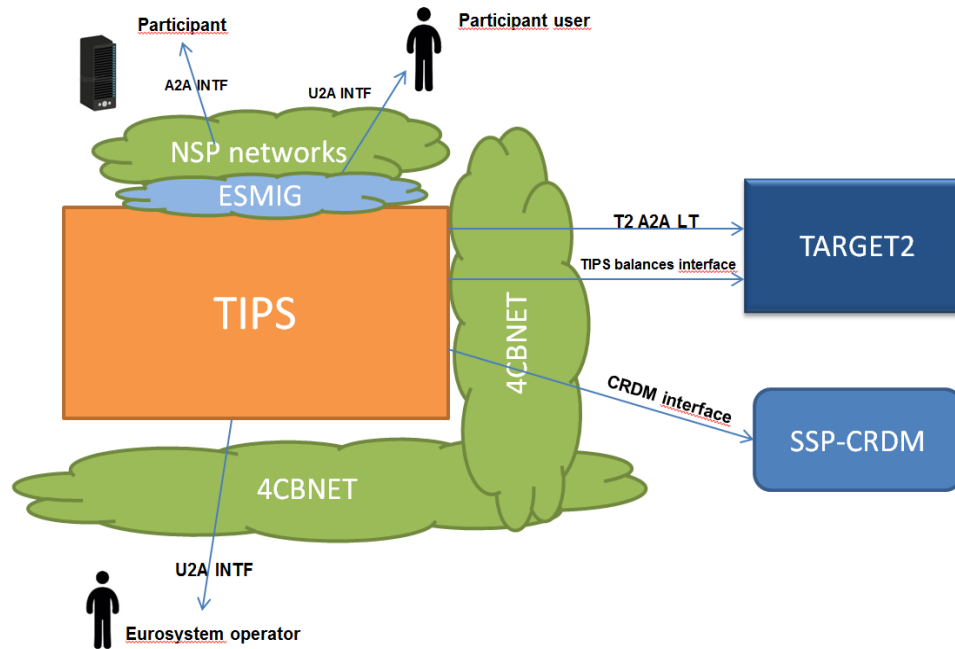
# The UHB scope

The structure of the UHB is based on five main parts (chapters):

- **Chapter 1** provides an introduction to the TIPS service, its main settlement features and the architecture of the underlying platform. It is intended as an introduction to the service and it does not contain information that is not already available on Chapter 1 of the UDFS. Interactions of TIPS with other services (e.g. TARGET2, ESMIG, CRDM, etc.) are also in the scope of this chapter.
- **Chapter 2** provides a description of the structure of the UHB itself and an overview of the GUI structure (menu, screens and field types).
- **Chapter 3** describes the main reference data objects (since their maintenance is handled in the CRDM service, only a general description is provided here).
- **Chapter 4** provides a description of all the functions available via the TIPS GUI and the details of every related screen.
- **Chapter 5** provides a detailed step-by-step description of all the GUI functions, enabling the user to trigger and use the available U2A functions.

## ➤ Description of reference data objects:

### 3.1.1. Types of TIPS Actors

#### 3.1.1.1. TIPS operator

The **TIPS Operator** is the legal and organizational entity that operates TIPS. They are responsible for the initial setup and day-to-day operations of TIPS and act as a single point of contact for Central Banks and directly connected TIPS Actors. They are responsible for monitoring the system and carrying out corrective actions in case of incidents or in the event of service unavailability. The TIPS Operator is also responsible for setting up and maintaining Central Banks reference and, if required, they may operate on behalf of any TIPS Actor. They have full access to all live and all archived reference data and transactional data in TIPS.

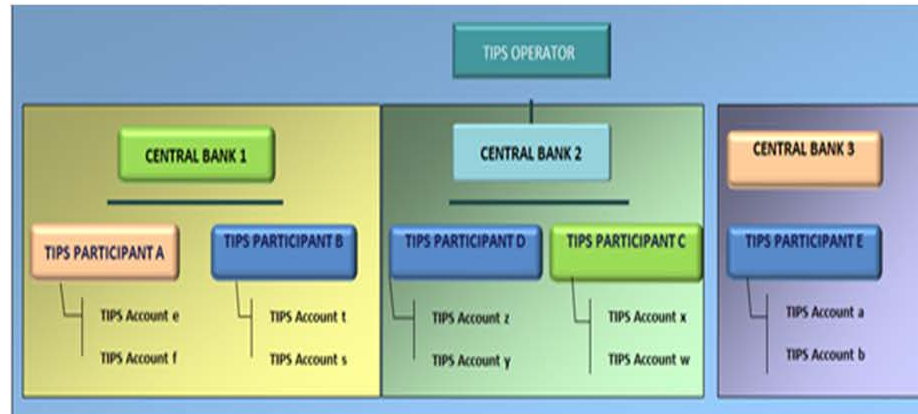
#### 3.1.1.2. Central Bank

**Central Banks** are responsible for setting up and maintaining reference data for all the TIPS Actors belonging to their national community. Central Banks provide liquidity to Participants through Liquidity Transfers from the relevant RTGS and can also act as Participants
