The Version 1.1 of the Catalogue is based on:

- The version 1.9 of the “CSDs’ Reference Data Extension” (11 new rules + updates on existing ones)
- The results from the sanity check performed on the “Insolvency Procedures” business process after the implementation of CR558 in November 2016 as part of the T2S Release 1.2.

- From the total 40 restriction rules under the “Insolvency Procedures” business process:
  - ✓ 9 were deleted
  - ✓ 4 were moved to the “Static Data Configuration”
  - ✓ 5 were moved to the “Other Regulatory Compliance”
  - ✓ 1 was moved to the “Operational Procedures”
  - ✓ 21 remain under the “Insolvency Procedures”
- From the 14 MSAs needed in the context of the “Insolvency Procedures” business process, 7 MSAs are no longer needed.
