1. Introduction

T2 started operations on business day 20 March 2023 following the testing of the software in 3 test stages: 1) the Euro system Acceptance Testing (EAT) performed by the Eurosystem as a whole, 2) the Central Bank Testing (CBT) conducted by Central Banks and 3) the User Testing (UT) executed by Central Banks and Participants.

During these test stages, some software limitations have been identified. While most of the limitations have been resolved, the remaining and the ones identified after the go-live, are being gradually lifted during the ongoing operational phase.

Many fixes have been deployed with the standard T2 releases R2023.NOV and R2024.JUN. Some more fixes are planned with the T2 release R2024.NOV and beyond.

The objective of this document is to provide an overview of those limitations and their resolution timeline in such a way that Central Banks and Participants are aware of these, adapt their processes accordingly and avoid raising incidents against the documented limitations.

This document will present the limitations in two categories:

- 1. Functionalities not yet released nor delivered
- 2. Functionalities delivered with restrictions.

Deleted information compared to the previous version is flagged in red, new information is shown in green.

This document includes an annex (Production conditions document - Annex A – PBI extract) which provides further descriptions on open defects including the Business Oriented Descriptions (BOD).

Both this T2 Production document and its annex are being revised fortnightly to provide users with the latest updates on the software evolution.

2. Functionalities not yet released nor delivered

All functionalities relevant for participants have been released in PROD.

3. Functionalities delivered with restrictions

This category includes the participants functionalities delivered to PROD but impacted by open defects.

The section is divided in sub-sections which relate to specific components (e.g. CRDM, CLM, etc). Each component sub-section is introduced by an overview followed by a list of open defects. For each open defect, the list includes the PBI number i.e. problem reference, the description of the problem and target delivery date of the fix in the production environment. The target delivery date "To be confirmed" refers to any of the following cases: 1) a fix to the problem has already been delivered but still needs to be confirmed as successfully retested by the users or 2) an unsuccessful retesting or the problem is still under analysis.

3.1 CRDM

3.1.1 Overview

CRDM functionalities are released with restrictions. This component is still impacted by open defects presented in the following section.

Note: the participants are requested to follow the recommendations described in the document "<u>CLM/RTGS Reference Data / recommendations for setting up data in CRDM</u>" to avoid data inconsistencies that might hamper the business day processing. This document will be shared by the relevant National Service Desk (NSD).
