MONETARY DEVELOPMENTS IN THE EURO AREA: MAY 2013

The annual growth rate of the broad monetary aggregate M3 decreased to 2.9% in May 2013, from 3.2% in April 2013.¹ The three-month average of the annual growth rates of M3 in the period from March 2013 to May 2013 stood at 2.9%, unchanged from the previous period.

M3 components

Regarding the main components of M3, the annual growth rate of M1 decreased to 8.4% in May 2013, from 8.7% in April. The annual growth rate of short-term deposits other than overnight deposits (M2-M1) stood at 0.0% in May, compared with 0.1% in the previous month. The annual growth rate of marketable instruments (M3-M2) was more negative at -15.7% in May, from -13.9% in April. Among the deposits included in M3, the annual growth rate of deposits placed by households increased to 4.3% in May, from 4.0% in the previous month, while the annual growth rate of deposits placed by non-financial corporations increased to 6.4% in May, from 6.2% in the previous month. Finally, the annual growth rate of deposits placed by non-monetary financial intermediaries (excluding insurance corporations and pension funds) decreased to 5.5% in May, from 8.3% in the previous month.

Counterparts to M3: credit and loans

Turning to the main counterparts of M3 on the asset side of the consolidated balance sheet of Monetary Financial Institutions (MFIs), the annual growth rate of total credit granted to euro area residents decreased to -0.2% in May 2013, from 0.0% in the previous month. The annual growth rate of credit extended to general government decreased to 3.2% in May, from 3.5% in April, while the annual growth rate of credit extended to the private sector stood at -1.0% in May, compared with -0.9% in the previous month. Among the components of credit to the private sector, the annual growth rate of loans was more negative at -1.1%

in May, from -0.9% in the previous month (adjusted for loan sales and securitisation², the rate was more negative at -0.7%, from -0.5% in the previous month). The annual growth rate of loans to households decreased to 0.2% in May, from 0.4% in April (adjusted for loan sales and securitisation, the rate stood at 0.3%, unchanged from the previous month). The annual growth rate of lending for house purchase, the most important component of household loans, decreased to 1.0% in May, from 1.2% in the previous month. The annual growth rate of loans to non-financial corporations stood at -3.1% in May, compared with -3.0% in the previous month (adjusted for loan sales and securitisation, the rate was more negative at -2.1% in May, from -1.9% in the previous month). Finally, the annual growth rate of loans to non-monetary financial intermediaries (excluding insurance corporations and pension funds) decreased to 0.2% in May, from 0.6% in the previous month.

Other counterparts

Over the 12 months up to May 2013, the net external asset position of the euro area MFI sector increased by €261 billion, compared with an increase of €205 billion over the 12 months up to April. The annual growth rate of longer-term financial liabilities of the MFI sector was less negative at -0.9% in May, from -1.4% in April.
